


Installing the cable-management brackets in a rack

The cable-management brackets help you route and organize cables in the rack when there are at least three Lenovo NeXtScale n1200 Enclosures. The cable-management brackets are installed in a Lenovo 42U 1100 mm Deep Dynamic Rack.

You can install up to four cable-management brackets in the rack. Depending on how the rack is configured, you can install two brackets in the upper half of the rack on the left and right sides and two brackets in the lower half of the rack on the left and right sides.

To install the cable-management brackets in a rack, complete the following steps:

- 1. Install five special clip nuts in the holes on the inside left front of the rack in the applicable holes.
- 2. Orient one cable-management bracket vertically with the horizontal rubber-coated bars facing the inside of the rack.
- **3**. Position the cable-management bracket so that it is flat against the inside left front of the rack, making sure that the five screw holes on the bracket are aligned with the holes in the front inside of the rack where you installed the clip nuts. See the following illustration.



- 4. Secure the cable-management bracket to the rack with five M5 screws.
- 5. Use the hook-and-loop fasteners that are attached to the cable-management bracket to neatly route the cables.
- 6. Repeat step 1 on page 4 through step 5 to install each cable-management bracket on the inside front of the rack.
